PRESIDENTS' MESSAGE

I would like to thank Al & Fran Avilla for hosting the annual Ridgewood Holiday Party at their home. I hope that everyone who attended enjoyed the party.

I would also like to thank everyone who brought donations of food items to the holiday party. As we all know these are very hard times for a lot of people/families in Tuolumne County. Interfaith Food Bank accepts donated food items and distributes them to people in need. All the food items donated by Ridgewood residents were delivered to Interfaith Food Bank located at 18500 Striker Ct, Sonora. The Amador Tuolumne County Action Agency (ATCAA) accepts monetary donations and uses the money to purchase food for people in need. ATCAA is located at 427 N. Highway 49, Suite 301, Sonora. All checks should be made out to ATCAA/food bank.

I am sure that most Ridgewood residents have noticed the drainage problems at the corner of Ridgewood Drive and Parkridge Avenue. After studying the situation carefully, it looks like the problems are caused by several poorly designed drainage systems.

As many of you know, Parkridge Avenue is not a Tuolumne County maintained road. Actually, Ridgewood Drive is the only road in Ridgewood that is maintained by the County. All other Ridgewood roads are maintained through a County Service Area (CSA). I contacted our Ridgewood CSA administrator and she said we have a contract that has been signed to check all the Ridgewood CSA drainage systems and make sure all culverts, ditches & roadside drains are clear. Our Ridgewood CSA administrator also mentioned that the work will begin shortly and that she will suggest that the drainage problems on Parkridge Ave., described above, will become one of the first items of work.

There are several places in Ridgewood where the weeds and brush are growing right up to the edge of the road. The Tuolumne County Agriculture Department is planning to do weed abatement spraying and brushing on all Ridgewood CSA roads. The spraying and brushing will be limited to within 5 feet off the edge of the pavement. They have assured me that they will not spray, or brush, ornamental shrubbery.

There are several steeply sloped banks in Ridgewood that have been sprayed with herbicides to remove vegetation. While spraying eliminates weed growth it can also cause drainage problems during the wet season, especially when the ground is sloped. In many cases the soil has moved down into the street clogging the storm drains. I spoke to a landscape designer and he recommends reseeding the banks with annual rye grass until the natural vegetation returns. Of course other types of plants can also be used to control erosion. Annual rye grass can be purchased at most hardware stores in Sonora. Sonora Feed and Supply, located at 13765 Terrace Dr, Sonora, sells annual rye grass by the pound.

I am sure many residents have noticed that there are no fire hydrants on Ridgewood roads other than Ridgewood Drive. It is our understanding that there is some plumbing installed. We have contacted our county CSA administrator and she provided preliminary information. We are just beginning to look into this situation. If decide to do something about the fire hydrant problem, it will not be funded using CSA money. There may be little we can do about the fire hydrant situation, but it is certainly seems worth investigating.

LEASH LAWS IN RIDGEWOOD

The California leash law says that if the dog is off the owners property it must be on a leash.

All around Ridgewood are signs placed that there is a Leash Law in Ridgewood and that they will be enforced. There has even been an altercation at least once where the dogs ON LEASH were attacked by dogs not on leash.

Pet owners who allow their pets to roam unattended are putting the animals' welfare in jeopardy and creating a nuisance to neighbors, other domestic pets and wildlife.

PROPANE PRICE CHANGE

Some Residents may have recently noticed a slight increase in our delivered price for Propane. Amerigas has increased the Ridgewood purchase price to \$.57 above the Posted Price published by the California Department of Government Services. Amerigas explains that their "laid in" costs have gone up due to increased transportation costs to their Plant in Angels Camp. For your convenience Amerigas has agreed to provide weekly, Ridgewood's Propane price for the coming week to be posted on the Ridgewood Web Page. This is to offset recent inconsistencies by the Dept. of General Services to provide updated price information that we will continue to monitor, when made available.
