Ridgewood 108 Firewise

<u>Outgoing Firewise Message – Dennis Hebert</u>

I would like to thank Michael Moore for taking responsibility for the Ridgewood 108 Firewise chair. Going forward, Firewise will continue to be an important function for all Ridgewood residents. With the Washington fire, we have all experienced the scare that our community is very vulnerable to being destroyed by fire. Being prepared for an evacuation and knowing what routes to take is key to our survival, and I encourage all residents to sign-up for the Everbridge emergency notification. This service still has some problems, but we need to work with the county OES to ensure that the problems with this service are corrected and all residents are notified. We also need to coordinate with other Firewise committees in Tuolumne County to have a stronger voice with the County OES. Compared to other counties, we are very weak in getting grants and other tools necessary for wildfire mitigation. One of the points that I took away from our RNA meeting is that we need to incorporate some guidelines in our CC&R's for empty lots. This will be difficult, but it is important that these empty lot owners understand that they need to comply with CC&R's.

I would also like to acknowledge the majority of residents in Ridgewood for maintaining their own property. Defensible space is a key ingredient for wildfire mitigation and Ridgewood residents do an excellent job in keeping their property and our community safe. This has made the Firewise goals very easy for me to administer and I know that Mike will appreciate all the hard work by residents in the future.

New Firewise Chair - Introduction

As a new member of the Ridgewood community, I would like to introduce myself. My wife and I moved to the neighborhood last November. Neighbors,

It was a pleasure to meet all of you that were able to attend the Ridgewood Neighborhood Association board meeting and car show. I'm looking forward to meeting more of you at the next event. As we finish up the summer months and look towards the Holidays, be aware that scammers may be gearing up as well. Scams can present in many forms, however telephone scammers are the most common and will take any opportunity to convince you they have a legitimate need for any of the following: paying "outstanding balances" for credit cards or utility bills by money order or gift cards, asking for social security numbers and other forms of personal identification and money orders to clear arrest warrants/threatening arrest for you or your family members, just to name a few. Never give out personal information over the phone if you did not initiate the phone call directly to a number you trust. You can always hang up and dial the number of the institution you know to be correct or call the non-emergency line at the Sheriff's Office if there is a threat of law enforcement use against you.

Also, as an important reminder as we just experienced the Washington Fire and many think we are headed out of fire season as the weather cools down, fire season will continue over the next few months and every household should have a plan for emergency evacuation. Propane Reminder

Please, do not discuss Ridgewood's pricing with others outside Ridgewood to protect our ability to obtain special prices.

Be aware TARGA prices change daily, which is why you are encouraged to go to the TARGA S.F. price as published by the Butane Propane Newsletter (BPN) that can be located at: https://www.dgs.ca.gov/PD/Resources/Page-Content/Procurement-Division-Resources-List-Folder/Liquefied-Petroleum-Gas-Fuel-Postings/ then add the price per gallon offered by the Supplier.

Through December 31, 2021, Ridgewood residents are provided the following prices from the noted suppliers:

Campora Propane: TARGA S.F., plus \$0.56/gal. Phone #209 532-3579

JS West Propane: TARGA S.F., plus \$0.65/gal. Phone #209 532-7475

2021 Cal Sierra Transfer Stations Voucher

If you haven't picked up your two (2) vouchers per customer that may be used together or separately during the calendar year, call 209-532-1413 **before** going to the Waste Management office. Provide your account information and they will confirm you are in good standing and make your vouchers available for pick-up. Each voucher is good for free disposal of up to one-cubic yard of solid waste not more than 240 lbs.

Thank you to those who stepped up to fill our open positions and support the continuation of the Ridgewood Neighborhood Association. The following positions are still looking for volunteers:

Block Captains (Ridgewood II & III):

2nd Block Caption Co-Chairperson and Block Captain 8 (Parkridge Ave/Pineridge Ct). Refer to Block Captain Guidelines. Ridgewood I is identified as Block 0 (Ridgewood Web Page @ ridgewood.netfirms.com; "Maps" Tab; "Block Captain Map for Ridgewood II & III").

Summary of the neighborhood block captains duties include:

- * Promoting neighborhood security
- * Encouraging neighborhood communication
- * Welcoming new neighbors, giving them a new neighbor packet
- * Initiating a "telephone tree" for their blocks in the event of an emergency
- * Notifying their deputies when they are out of town

Ridgewood Neighborhood Summer Party, Car Show and Meeting

Positive comments about the party/meeting/car show were received immediately following the event, and a number of e-mails were received afterwards as well.

We had a wonderful turnout for our Summer get together on September 12th. Thank you to all who participated in the neighbors-only car show. There was an informative panel discussion with Ryan Campbell, Supervisor District 2; David Goldemberg, Supervisor District 1; Bill Pooley, Tuolumne County Sheriff; Emily Kilgore, Cal Fire Representative and Dore Bietz, Office of Emergency Services/Firewise Representative.

Questions presented to the Supervisors:

1. Road maintenance on the entirety of Ridgewood Dr. is desperately needed (weed abatement, repair of curbs from last winter's snowplowing, potholes). Would you be able to help us get that accomplished?

Ridgewood Dr. is included in the current, and next two years, repair plan. Tom Crosby asked if the residents could be given the opportunity to prioritize the work on Ridgewood Dr. The answer was yes, to reach out to Kim McFarland. Work orders can be submitted on-line via the website. Let Ryan know when contact with Kim has been made, providing photos is helpful, and he'll follow-through with the appropriate departments and personnel.

2. Nate's Tree Service has done some tree removal work in our area. Thank you! We'd like to arrange to have more of that done. Who arranged for and paid for that? Who do we speak to schedule additional tree removals? Additionally, some trees were badly pruned and need to be fixed however the homeowner(s) have not been successful in getting the company to come back to fix the mistakes.

Nate's Tree Service was given a contract from PG&E to trim and remove trees, and clean-up, shred, take away the debris. If mistakes need to be addressed contact PG&E as Nate's needs to be held accountable. As far as getting additional work done, not sure if that is possible although OES is also addressing this.

3. Fire Insurance! Is the county involved at all with the issues that homeowners are having in not only securing, but keeping fire insurance policies? What can the county as a whole do to combat the insurance companies that are cancelling policies and raising the rates so high?

Ryan is also very concerned about this issue. There is a push underway to change how residential developments move forward – to prohibit developments due to fire risks. The county and state are tackling the issues but the state isn't allowing much input from the counties (who know what is needed, where, when, how, etc.). At this time there is no county-wide ordinance to force vegetation management. Other counties do have such ordinances and Tuolumne County is working on it (Bietz and Goldemberg are on the committee). Dore Bietz noted that \$250,000 has been allocated for weed abatement/code enforcement so if the property owner doesn't clean up their property then the county will do it and send a bill to the property owner and/or place a lien on the property. There are three issues being addressed and a 3-pronged approach to tackle the issues.

4. Please tell us about the upcoming re-districting.

This is still under discussion, no decisions made at this time. The public will be given the opportunity to provide input. Right now, the districts have very unequal populations so an effort will be made to equalize the number of people in each district.

5. We continue to research grant opportunities, and other funding, to implement fire mitigation efforts. Can the county help us at all with that effort?

Dore has suggestions and can offer assistance. Efforts to contact her to gather the information will be pursued immediately.

Other points of discussion from the panel:

Escape Routes: Law enforcements/T.C. Sheriff is responsible for handling evacuation notifications. Know your neighbors! Know if they'll need help should an evacuation be necessary. When law enforcement tells you to leave, leave. If you don't leave when instructed they will not come back for you – too risky, dangerous and they won't have the time. Be prepared to save yourself and neighbors that may need assistance – do not count on law enforcement and fire protection as they are very short staffed (although notify law enforcement if you know a neighbor needs assistance and you can't offer it). Have a plan! Have your important papers, pets, personal items ready to go. Get reliable information only from Sheriff or Cal Fire sources (Facebook, Twitter, etc.), don't rely on other social media as info could be outdated or just flat-out incorrect. Law Enforcement agencies and OES work cooperatively.

Evacuation Warning Definition: A warning will be issued to allow residents time to packup and prepare to leave. Leave then if desired, especially if extra time is required.

Evacuation Order Definition: This means to leave now!
